1. WHEREAS the Founder & Trustees of this Public Trust are desirous of rendering public and educational service etc. by instituting a public charitable and Educational Trust.

2. WHEREAS the Founder & Trustees with a view to give effect to the said desire, constituted a Trust in the name and style of "SRI RAMAJAYAM EDUCATIONAL TRUST".

- 3. WHEREAS the MAIN OBJECT OF THE TRUST SHALL BE " IMPARTING PRIMARY, SECONDARY AND HIGHER SECONDARY SCHOOL EDUCATION UNDER THE COURSES OFFERED BY THE TAMILNADU STATE GOVERNMENT OR THE CENTRAL GOVERNMENT i.e., the GOVERNMENT OF INDIA OR ANY OTHER BODY APPROVED BY THE STATE OR CENTRAL GOVERNMENT " and such other related subjects on education and training as the Founder & Trustees agree to do.
- 4. WHEREAS at the time of execution of these presents, the Founder & Author of the Trust Sri. Rama Elumalai has transferred and delivered to the Trustees mentioned above a sum of Rs. 10,008/- (Rupees Ten thousands and eight only) by cash with a view to rest with the Trustees as a nucleus of property
- 5. WHEREAS the Founder & Author of the Trust has declared that the aforesaid sum of Rs. 10,008/- (Rupees Ten thousand and eight only) and all further donations and contributions and any property that may be acquired or mobilized to the Trust by the Founder, Trustees or other persons and interest, rent, dividend, profit and income arising thereafter herein referred to as the "Trust Property", should be held upon the trust for the objects and purposes hereinafter mentioned and subject to the powers and conditions hereinafter declared and contained in the same; AND
- 6. WHEREAS the Trustees hereto have agreed to join and manage and administer the same collectively as a committee on the regulations hereinafter appearing.

# NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:

#### 1. NAME OF THE TRUST:

The Trust hereby declared and constituted as a Public Charitable Trust and shall be designated as "SRI RAMAJAYAM EDUCATIONAL TRUST" hereinafter called as the Trust.

# REGISTERED OFFICE:

The Registered Office of the Trust shall be at No.152, THRUMANGAI ALWAR STREET, SRIPERUMBUDUR TOWN & TALUK, KANCHIPURAM DISTRICT, TAMILNADU - PIN 602105.

#### 3. **OBJECTS OF THE TRUST:**

- A) To establish, to take over or acquire and maintain and manage schools, colleges and other educational institutions, Residential schools, hostels, orphanage and charitable organizations.
- B) To award scholarships, stipends to students in India and to enable their studies in India or in foreign countries and for purchasing books, to award prizes to students for proficiency in any subjects or languages and to promote or encourage sprit of sports among student community.

- C) To promote study and research in any subject and afford facilities to those who conduct such study and research on any subject or field of science or Engineering or Technologies etc.
- D) To give financial or corporal aid assistance or other help to deserving persons individual or community or society.
- E) To impart training for advancement of knowledge in any subject or languages or discipline.
- F) To give subscriptions or donations to any charitable institutions or body with proper recognition.
- G) To accept, upon such terms as they shall think fit, any donations, grants, subscription, aid and contributions from any Government, local authority, corporation, firm, company syndicate, association, or other person or from any charitable or other institution whether they be in cash or in other movable or immovable property for the purposes of the trust PROVIDED ALWAYS that the terms upon which they shall be accepted shall not in any way be inconsistent with or repugnant to the provisions contained in these presents and such donation, grants, aids, subscriptions and contributions shall be applied for all or any of the objects of the Trust.
- H) To acquire by purchase, lease or otherwise any property whether movable or immovable or any rights for the purposes of the trust and to sell, give on lease mortgage or otherwise transfer any such property or rights.
- I) To construct, maintain or alter any building or works necessary for the purpose of the trust.
- J) To borrow money for the purposes of the Trust upon any terms and conditions either with or without interest.
- K) To receive grants from any agencies including Central Board for the workers Education and to conduct program for them.
  - L) To do such activity / activities for furtherance of Art, Literature, Music etc.,
- M) To provide financial assistance or grants, scholarships, stipends etc for the protection and preservation and for development of ancient Tamil folk arts like, Karagam, Silambam, Bommalattam, Yoga etc and to provide awards to artists and Masters of such ancient arts
- N) To spread knowledge and education by publication of books, periodicals, journals, literature etc.,

- O) To give monetary aid or other help for relief from natural calamities like floods, cyclone, tempest or otherwise, to give monetary aid or other help for the disposal of dead persons or cremation or performance of obsequies.
- P) To give aid for the promotion of agriculture, horticulture and the like and for research in the same subjects.
  - Q) To assist renovation of places of historic, archaeological or artistic importance.
- R) To do all such other lawful things as may be considered incidental or conducive to the attainment of the objects mentioned above.
- S) To conduct various program for including moral and spiritual values , civic sense, social awareness, respect for the rule of the law, concern for environment and concern for all living creatures among parents, students and the youth and to make them aware of India's heritage and culture

#### 4. **INVESTMENTS:**


All monies which shall not immediately be required for current expenses shall be invested by the Trustees in investments and securities authorized by law according to the provisions of Section 13 (1) (d) read with section 11(5) of the Income Tax Act 1961 or other relevant provisions of law for the time being in force and shall be in the name of Trust only.

#### 5. TRUST FUND:

The Authors of the Trust declare that the sum of Rs. 10,008/- (Rupees Ten thousand and eight only) that has been dedicated by them for public charitable purposes and objects of general public utility described above, the receipt of which the TRUSTEES have acknowledged and that the TRUSTEES shall and will stand possessed of the said sum of Rs. 10,008/- (Rupees Ten thousand eight only) upon Trust and also any other properties, movable or immovable, which the Trustees may from time to time receive for augmenting the Trust Fund or for specified purposes connected with the objects of the trust not calculated to impede the due working of the trust arising from donations, bequests, gifts, legacies or grants in such or kind or from any other source whatsoever and also of any investments for the time being representing the same (hereinafter called the Trust Fund) and also of the net income from the Trust Fund into Trust, and to apply both the income and the capital of the Trust Fund for the purposes of the Trust.

If Present the Trust has no movable (or) immovable property other than initial fund.

The Trust Fund shall be held in the name of the Trust and not in the name or names of the TRUSTEES.





If the objects for which this Trust has been created shall fail or cannot be satisfactorily fulfilled for any reason, the Board of Trustees shall be at liberty to apply the Trust Fund or any portion thereof to any other Trust or institution having objects wholly or in part similar to this Trust.

#### 6. THE TRUSTEES:

(a) The First Board of Trustees of the Trust shall consist of the following persons:-

#### 2. AS VICE CHAIRMAN

# 3. AS SECRETARY E. VARADHARAJAN, S/O. RAMA ELUMALAI, 12, Thirumangai Alwar street, Sriperumbudur -602105

- b) The Board of Trustees shall consist of not less than 2 and not more than 11.
- c) The Trustees shall be trustees for their life time, or till their seat comes vacant or is vacated by due process.
- d) The number of Trustees may be altered according to the decision of the Board of Trustees subject to (b) supra.
- e) The Trustees shall hold such office as Trustee during their life time unless they should vacate the office earlier for any reason whatsoever. In the event of there being a vacancy in the office of such trustees, it shall be filled up by co-option by remaining trustees. In the event of a Trustee retiring on his/her own, the person nominated by him/her behalf shall take the place of such retiring if the remaining Trustees co-opt for the same.

# 7) POWER OF THE BOARD:

- A) The Board of Trustees shall have all powers necessary or incidental for effectually carrying out the objects of the trust.
- B) Subject to the general provisions of the Trust and without prejudice to the general and specified powers conferred by the other provisions contained in THESE PRESENTS, the Board of Trustees shall have the following powers also.
- a) To apply the trust monies to effectuate one subject or some of the objects of the trust in preference of the other objects.
- b) To discontinue the application of the Trust funds to one object and divert the funds to another object.
- c) To determine the terms and conditions on which any donations, subscriptions, scholarships or prizes are to be given by Trust.
- d) To extend the funds of the Trust in such manner as they shall consider most beneficial for the purposes of the Trust.
- e) To acquire, build, re-build, and to alter, repair, improve, sell or dispose off or otherwise deal with any land, building or premises or property of the use of the Trust.
  - f) To take any property on lease or hire.
  - g) To acquire any property.
  - h) To enter into any contracts on behalf of the Trust.
- i) To borrow any money upon the security of any property of the Trust, sign promissory notes, bills of exchange, hundies or any other financial documents and to grant mortgages for securing the same or without any documents and to grant mortgages for securing the same or without any security and upon such terms and conditions that the trustees may deem fit.
- j) The trustees shall have power to collect rent, interest or other income and invest the Trust Fund and vary such investments from time to time and sell or realize the investment for the purposes of the Trust. The Trustees shall have powers to mortgage, raise loans or encumber, sell or lease out or otherwise alienate the immovable properties, if any of the trust; unless and until necessity or occasion compels such a sale, transfer or encumbrance or other alienation of the immovable properties. In any such event, the Managing Trustee shall be competent to sell, lease, encumber or otherwise alienate the properties of the trust, after due authorization by the Board of Trustees and they two are authorized to enter into or execute all such document deed instrument of all kinds for and on behalf of the TRUST.

- k) To lend or invest the surplus funds of the Trust in such manner as may be decided by the Board of Trustees.
- I) To incur all such expenses as are necessary for the execution of the Trust and powers under these presents.
  - m) To raise donations or accept gifts or contributions in such be in kind.
  - n) To appoint legal auditors to audit the accounts of the Trust.
- o) To appoint legal advisers, Engineers, Technocrats, valuers, appraisers, experts etc. for the Trust.
- p) To reimburse the Trustees towards the pocket expenses which may be incurred by them in the course of, or in relation to the affairs of the Trust.
- q) To receive donations, contributions, gifts, bequests, legacies and endowments from individuals, charitable to other trust or institution for the objects of the trust on such terms and conditions as may be accepted by the trustees.
- r) To make, alter, rescind any rules or regulations in regard to the conduct of affairs in respect of which any power or duty is vested in them for the convenient and effective management and administration of the Trust.
  - s) To make and from time to time repeal or alter the regulations.
    - i) as to the details of management of the trust and the affairs thereof.
    - ii) as to the duties of any officers or servants of the trust.
- iii) as to the conduct or any of the matters or things within the powers or under the control of the Board provided that the same shall not be inconsistent with the provisions contained in these presents.
- t) To settle out of the court, compromise or compound all suits, actions and other proceedings and all differences or demands and to refer all or any of such differences or and approve all accounts without being answerable for any loss occasioned thereby.
- u) To appoint and dismiss manager, teachers, clerks and other staff and at their discretion remove, dismiss or temporary or special service in connection with the work of the Trust, Trust estate, Trust fund and Trust properties as they may from time to time think fit and to determine their powers and duties and fix their salaries, bonus or emoluments and to require security in such instance and such amounts as the Trustees may think fit. The Trustees shall also have power to found and maintain, provident funds, gratuity funds, personals and other funds for any employees and make rules and regulations regarding the same.
- v) To do or consider and implement other incidental affairs or activities, as deem fit related these aims and agreeable to law.

w) No bonafide act or proceedings of the Board of Trustees shall be deemed to be invalid by reason only of any defect in the appointment or constitution of the Board of Trustees or any member thereof or on the ground that any member of the Board of Trustees was not entitled to hold or continue in office by reason of any irregularity in his appointment or by reason of such act having been done or proceedings taken during the period of vacancy in office or of office bearers or of any Trustee or by any reason of ineffective delivery of the notice of the meeting of the Board of Trustees.

## 8. CUSTODY OF DOCUMENT:

The Managing Trustee shall have the custody of all deeds and documents of title relating of Trust Properties and investments and the books of account and other records relating to the trust and shall be responsible for the same and their safe custody.

#### 9. BANK ACCOUNT:

All income, subscriptions and pecuniary donations for the general purpose of the trust and the income of investments and all other moneys from time to time forming part of the general revenue of the Trust shall on the same being receipted to be paid into a bank account for accounts with any scheduled bank or banks which the board may determine. Such bank accounts may be operated by Managing Trustee only.

## 10. ACCOUNTS AND AUDIT:

- a) The Managing Trustee shall keep proper accounts of the income and expenditure of the Trust and he shall prepare a financial statement and Balance Sheet for every year as on the last date of 31st March
- b) The accounts shall be got audited by a Chartered Accountant appointed by the Trust for this purpose and who shall not be a member in board;

# 11. TERMS OF OFFICE OF THE TRUSTEES:

The First Trustees of the Trust shall hold office for life or until they resign. Thiru. RAMA. ELUMALAI shall be the Managing Trustee. The other trustees shall hold such office assigned to them as per clause 6(a) of the Trust Deed and shall be for life and thereafter the post shall be filled up by election of any of the trustees existing at the time of vacancy.

## 12. POWERS TO CO-OPT:

The Trustees shall have the power to co-opt additional Trustees or to fill up any existing vacancy in the Board of Trustees. However, that the total number of Trustees shall not be in low or exceed the number fixed in 6(b) supra.

# 13. VACANCIES OCCURING IN THE OFFICE OF THE TRUSTEES:

The vacancies occurring in the office of the Trustees shall be filled by the remaining Trustees within 3 months of the arising of such vacancies. If there are no Trustees, functioning of at any point of time, the TRUSTEES shall be appointed in

accordance with the law by a Court of competent jurisdiction. Where at any time the number of TRUSTEES fail below the minimum prescribed in clause 6(b) supra, the continuing TRUSTEES shall have the power to co-opt any person or persons to fill up such vacancy.

# 14. VACANCY NOT TO INVALIDATE THE PROCEEDING:

Any Vacancy in the Board of Trustees and / or any illegality in the appointment of Trustees or their proceedings shall not invalidate any prior act or decision of the Board of Trustees.

# 15. ADMINISTRATION:

The Board of Trustees shall have full power and authority to administer the trust, its properties and affairs and to do all acts, deeds and things which are calculated to fulfill the performances of which the TRUST is established.

# 16. PROCEEDINGS OF THE TRUSTEES:

The Board of Trustees may meet as often as may be necessary for the efficient conduct of the Trust. The TRUSTEES may take decisions on any matter either at their meetings or by circulation of resolutions on papers.

#### 17. QUORUM:

The minimum number of TRUSTEES to be present for conducting a Meeting of the Board of Trustees shall be Two

#### 18. **VOTING:**

Each Trustee shall have one vote. The opinion of the majority of the Board of Trustees present at a Meeting shall be final in respect of all matters relating to the Trust.

## 19. MINUTES, ACCOUNTS AND AUDIT:

The Managing Trustee shall maintain true and correct account of the Trust and correct record of their deliberations and get the accounts duly audited by a Chartered Accountant.

#### 20. **NET INCOME OF THE TRUST:**

The Trustees shall invest and recover the income of the Trust and shall provide for all costs, charges, incidental expenses including insurance premium expenses, ordinary repairs, etc. and all other outgoing and expenses for the management and administration of the Trust.

## 21. LIABILITY OF TRUSTEE OR TRUSTEES:

In the professed execution of the Trust and power conferred, no Trustee shall be liable for any loss to the Trust properties arising by reason of improper investment

made in good faith or for the negligence or fraud of any agent or employee employed by him or by any other Trustee hereof although the employment of such agent shall not strictly be necessary or expedient or by reason of any mistake or omission made in good faith by the Trustees or by reason of any other matter or thing except willful or deliberates fraud on the part of the Trustees, who alone may be subject to be made so liable.

#### 22 MISCELLANEOUS:

# It is hereby expressly declared that the Trust is:

- a) a public charitable Trust and is absolutely irrevocable
- b) Separate and distinct charitable Trust to carry out the said objects and run its management and administration independently, notwithstanding of the facts that donations/contributions received from or paid to other institutions/associations/Trust.
- c) In case the Trust could not continue or pursue its objects, the Trustees in their duly constituted Board meeting may decide the winding up of the Trust, on such winding up, the Trust funds, properties and other assets and liabilities, shall be handed over and vested with any other Trust/ organization with similar objectives with the permission of the relevant Income Tax authorities. On such distribution due to winding up, no Trustee shall be benefited directly or indirectly.
- d) The accounts of the Trust shall be closed as on 31st of March every year and shall be placed before the Trustees meeting every year duly audited by a qualified Chartered Accountant.
- e) The investment of funds of the Trust shall be made in accordance with the provisions of section 13 read with section 11(5) of the Income Tax Act, 1961 or any statutory modifications or reenactments thereof for the time being in force.
- f) The benefits of the Trust shall be applicable to all, irrespective of caste, creed, colour or religion.
- g) No activity of the Trust shall be carried out outside India. The activities of the Trust are restricted within India and the beneficiaries should be Indian citizens only.
- h) The activities of the Trust shall not be carried out with profit motive, but any incidental excess of income over expenditure shall be utilised for the objects of the Trust.

Rtshrling

- The seal of trust shall bear the inscription "SRI RAMAJAYAM EDUCATIONAL TRUST" and shall remain in the custody and control of the Managing Trustee.
- Any amendment to this Trust Deed shall be made with the express written prior j) permission of the Director of Income Tax (Exemptions)/Commissioner of Income Tax, under whose jurisdiction the Trust falls.
- No part of the Trust funds or income of the trust shall be applied for the direct or k) indirect benefit of the persons referred to in Section 13(3) of the Income Tax Act 1961, or any statutory modifications or reenactments thereof for the time being in force.
- If the Trust decides to alienate any immovable property of the Trust, howsoever (1) acquired by way of purchase, will, gift, donation or otherwise, for whatever reason, such an alienation shall be made only with the prior approval of the Director of Income Tax(Exemptions), Chennal or any such authority that the statute may prescribe from time to time.
- (m) The Trustees shall be entitled to be indemnified by the Trust Properties against the consequences of all lawful acts done by the Trustees in the course of and discharge of their duties as Trustees of the Trust and all costs, charges and expenses thereof.
- The Trust shall ensure that not more than 5% or any other percentage of the Trust funds authorized so by the Income Tax Act 1961 or any statutory modifications or reenactments thereof for the time being in force, shall be utilized for any religious purpose.


